PART V, SECTION B, LINE 5: THE CHNA ADVISORY COMMITTEE MET FOR THE FIRST TIME IN MAY 2024 TO DISCUSS THE PURPOSE AND REQUIREMENTS FOR CONDUCTING A CHNA AS WELL AS THE ROLE OF THE ADVISORY COMMITTEE. THE ADVISORY COMMITTEE CONSISTED OF JASPER COUNTY HEALTH DEPARTMENT, MERCYONE NEWTON MEDICAL CENTER, JASPER COUNTY GENERAL ASSISTANCE, CAPSTONE BEHAVIORAL HEALTH CENTER, PREGNANCY CENTER OF CENTRAL IOWA, AND THE NEWTON POLICE DEPARTMENT.

IN MAY 2024, INPUT WAS COLLECTED FROM PERSONS WHO REPRESENT THE COMMUNITY THROUGH A 43-QUESTION SURVEY DISTRIBUTED TO COMMUNITY MEMBERS AND ORGANIZATIONS THROUGHOUT JASPER COUNTY, INCLUDING, BUT NOT LIMITED TO, COMMUNITY-BASED ORGANIZATIONS, THE HOSPITAL, CLINICS, COUNTY EMPLOYEES, SCHOOLS, AND LOCAL BUSINESSES. THE SURVEY WAS AVAILABLE BOTH ELECTRONICALLY AND VIA A PAPER FORM, AS WELL AS IN BOTH ENGLISH AND SPANISH. PAPER COPIES AND ACCESS VIA AN IPAD WERE AVAILABLE DURING LUNCH AT A LOCAL RECOVERY COMMUNITY ORGANIZATION. IN ALL, 373 AREA RESIDENTS RESPONDED.

A COMMUNITY TOWN HALL WAS HELD IN SEPTEMBER 2024 WITH 82 LOCAL PARTNERS, INCLUDING COUNTY SERVICES, MEDICAL PROVIDERS, SCHOOLS, CHURCHES, COMMUNITY-BASED ORGANIZATIONS, COMMUNITY ACTION AGENCIES, AND PUBLIC SAFETY DIVISIONS, TO ASSIST IN PRIORITIZING COMMUNITY NEEDS.

MERCYONE NEWTON CONTINUED TO REFER PATIENTS TO MENTAL HEALTH RESOURCES IN THE COMMUNITY. THE HOSPITAL PARTNERED WITH INTEGRATED TELEHEALTH PARTNERS (ITP) TO EVALUATE PATIENTS THAT COME TO THE EMERGENCY ROOM WITH A MENTAL HEALTH DIAGNOSIS AND FACILITATE PLACEMENT IF NEEDED.

MERCYONE NEWTON PARTICIPATED IN THE JASPER COUNTY CARES COALITION, A COMMUNITY GROUP FOCUSED ON ENHANCING AWARENESS OF HEALTH AND HUMAN SERVICE RESOURCES AND PROMOTING COLLABORATION. THE HOSPITAL SHARED AVAILABLE RESOURCES WITH THIS GROUP AND DISSEMINATED COMMUNITY RESOURCES VIA SOCIAL MEDIA.

THE HOSPITAL EMERGENCY DEPARTMENT COORDINATED WITH CAPSTONE AND CENTRAL IOWA COMMUNITY SERVICES TO IDENTIFY HIGH-RISK PATIENTS WHO COULD UTILIZE THEIR SERVICES. MEETINGS ARE HELD QUARTERLY TO CONTINUE TO ENHANCE THE PARTNERSHIP. PLANNING CONTINUED FOR COORDINATION WITH NEWTON CLINIC ON AWARENESS OF THESE RESOURCES.

MERCYONE NEWTON MET QUARTERLY WITH LOCAL AUTHORITIES TO DISCUSS RESOURCES, PROCESSES, AND OPPORTUNITIES RELATED TO PLACEMENT OF PATIENTS EXPERIENCING MENTAL HEALTH AND/OR SUBSTANCE USE DISORDERS.

MERCYONE NEWTON CONTINUED TO PROMOTE AND PROVIDE KETAMINE CLINIC SERVICES, COMPLETING 472 KETAMINE TREATMENTS IN FY25. THE KETAMINE CLINIC OFFERS SUPPORT FOR PATIENTS WHO ARE DIAGNOSED WITH PTSD AND DEPRESSION.

THE HOSPITAL CONTINUED THE PLANNING PHASES OF RENOVATING THE EMERGENCY DEPARTMENT, INCLUDING ADDING A SECOND BEHAVIORAL HEALTH TREATMENT ROOM AND OUTFITTING BOTH BEHAVIORAL HEALTH TREATMENT ROOMS WITH UPDATED SAFETY EQUIPMENT.

MERCYONE NEWTON FINANCIALLY CONTRIBUTED TO DISCOVER HOPE 517 TO SUPPORT THEIR EFFORTS IN PROVIDING RECOVERY AND RESTORATION FOR THOSE STRUGGLING WITH ADDICTION.

SHORTAGE OF HEALTH CARE PROFESSIONALS:

MERCYONE NEWTON PARTNERED WITH MERCYONE DES MOINES TO PROVIDE AN ON-THE-JOB TRAINING PROGRAM FOR PATIENT CARE ASSOCIATES TRANSITIONING TO PATIENT CARE TECHNICIANS. MERCYONE NEWTON CONTINUED TO INVESTIGATE CRITICAL CARE PARAMEDIC STAFFING MODELS AND WEEKEND PACKAGE STAFFING MODELS TO ATTRACT MORE CANDIDATES, AND CONTINUED CROSS TRAINING STAFF TO HELP WITH SHORTAGES. THE HOSPITAL CONTINUED TO OFFER TUITION REIMBURSEMENT, SIGN-ON BONUSES, AND FLEXIBLE SCHEDULING TO ATTRACT TALENT.

MERCYONE NEWTON PARTICIPATED IN LOCAL CAREER FAIRS TO EDUCATE COMMUNITY MEMBERS ON HEALTH CARE CAREERS AND JOB OPPORTUNITIES. THE HOSPITAL ALSO PARTNERED WITH LOCAL HIGH SCHOOLS TO PROVIDE EDUCATIONAL PRESENTATIONS TO STUDENTS ON HEALTH CARE CAREERS AND OFFERED VOCATIONAL EXPERIENCES ONSITE TO MULTIPLE STUDENTS THROUGHOUT THE YEAR.

MERCYONE NEWTON CONTINUED TO EXPLORE INNOVATIVE WAYS TO DELIVER CARE THROUGH PARTNERSHIPS AND VIRTUAL CARE DUE TO THE SHORTAGE OF HEALTH CARE

IN FY25, THE HOSPITAL ASSISTED WITH PHYSICIAN RECRUITMENT INCENTIVES FOR ONE FAMILY PRACTICE/OB PHYSICIAN IN THE AMOUNT OF \$25,000 TO HELP SERVE THE HOSPITAL'S MEDICALLY UNDERSERVED PRIMARY SERVICE AREA.

MERCYONE NEWTON PROVIDED CLINICAL ROTATION AND PRECEPTORSHIP EXPERIENCES TO STUDENTS TRAINING IN VARIOUS DISCIPLINES, INCLUDING NURSING, LAB, PHARMACY, PHYSICAL THERAPY, AND OCCUPATIONAL THERAPY.

CHILDCARE:

MERCYONE NEWTON CONTRIBUTED FINANCIALLY TO THE NEWTON YMCA TO SUPPORT THEIR EFFORTS IN PROVIDING CHILDCARE PROGRAMS FOR JASPER COUNTY RESIDENTS. THE HOSPITAL INCLUDED INFORMATION ON CHILDCARE RESOURCES IN BIRTH PACKETS FOR NEW MOTHERS AND SHARED CHILDCARE RESOURCE INFORMATION ON SOCIAL MEDIA.

A WIDE RANGE OF PRIORITY HEALTH AND SOCIAL ISSUES EMERGED FROM THE CHNA PROCESS. MERCYONE NEWTON DID NOT DIRECTLY ADDRESS THE FOLLOWING NEEDS IN FY25 DUE TO COMPETING PRIORITIES, LACK OF RESOURCES, AND BECAUSE OTHER AGENCIES ARE ALREADY ADDRESSING THESE ISSUES: HOUSING, FOOD INSECURITY, AND TRANSPORTATION.

MERCYONE NEWTON MEDICAL CENTER:

FOR THE PURPOSE OF HELPING FINANCIALLY DISADVANTAGED PATIENTS, A THIRD-PARTY MAY BE UTILIZED TO CONDUCT A REVIEW OF PATIENT INFORMATION TO ASSESS FINANCIAL NEED. THIS REVIEW UTILIZES A HEALTH CARE INDUSTRY-RECOGNIZED, PREDICTIVE MODEL THAT IS BASED ON PUBLIC RECORD DATABASES. THEREFORE, MERCYONE NEWTON IS REPORTING ZERO ON LINE 3, SINCE THEORETICALLY ANY POTENTIAL CHARITY CARE SHOULD HAVE BEEN IDENTIFIED THROUGH THE PREDICTIVE MODEL.

FINANCIAL COUNSELING IS OFFERED TO PATIENTS ABOUT THEIR PAYMENT OBLIGATIONS AND HEALTH CARE BILLS. INFORMATION ON HOSPITAL-BASED FINANCIAL SUPPORT POLICIES, FEDERAL, STATE, AND LOCAL GOVERNMENT PROGRAMS, AND OTHER COMMUNITY-BASED CHARITABLE PROGRAMS THAT PROVIDE COVERAGE FOR SERVICES ARE MADE AVAILABLE TO PATIENTS DURING THE PRE-REGISTRATION AND REGISTRATION PROCESSES AND/OR THROUGH COMMUNICATIONS WITH PATIENTS SEEKING FINANCIAL ASSISTANCE.

SUMMARIES OF HOSPITAL PROGRAMS ARE MADE AVAILABLE TO APPROPRIATE COMMUNITY HEALTH AND HUMAN SERVICES AGENCIES AND OTHER ORGANIZATIONS THAT ASSIST PEOPLE IN NEED. INFORMATION REGARDING FINANCIAL ASSISTANCE AND GOVERNMENT PROGRAMS IS ALSO AVAILABLE ON HOSPITAL WEBSITES. COMMUNITY INFORMATION -

MERCYONE NEWTON IS A RURAL HOSPITAL IN JASPER COUNTY THAT PRIMARILY SERVES THE RESIDENTS OF JASPER COUNTY. THE POPULATION OF JASPER COUNTY IS 37,808 RESIDENTS ACCORDING TO LATEST CENSUS ESTIMATES, WITH A POPULATION DENSITY OF 52 PERSONS PER SQUARE MILE. MERCYONE NEWTON IS LOCATED IN THE CITY OF NEWTON, IOWA, THE COUNTY SEAT. NEWTON IS ABOUT 30 MILES EAST OF THE DES MOINES METROPOLITAN AREA. OLDER ADULTS (65+) REPRESENT 19.10% OF THE POPULATION, AND INDIVIDUALS UNDER AGE 18 COMPRISE 22.04%. THE POPULATION'S RACIAL MAKEUP IS PRIMARILY WHITE (93.82%), AND 2.79% OF THE POPULATION IS HISPANIC OR LATINO. NEARLY 30% OF INDIVIDUALS ARE LIVING IN HOUSEHOLDS WITH INCOME BELOW 200% OF THE FEDERAL POVERTY LEVEL.

PROMOTION OF COMMUNITY HEALTH -

MERCYONE NEWTON REMAINS FOCUSED ON IMPROVING THE HEALTH OF OUR COMMUNITY. MERCYONE NEWTON HAS AN OPEN MEDICAL STAFF AND IS PROUD TO OFFER A FULL SPECTRUM OF SERVICES, FROM FAMILY HEALTH SERVICES AND PRIMARY CARE TO SURGERY AND THE SKILLED CARE PROVIDED BY THE VISITING PHYSICIANS IN THE MERCYONE NEWTON SPECIALTY CLINIC. EMERGENCY SERVICES ARE AVAILABLE TO ALL REGARDLESS OF THEIR ABILITY TO PAY. THE HOSPITAL CONTINUES TO PROVIDE FREE AND DISCOUNTED CARE TO PATIENTS THROUGH THE HOSPITAL'S FINANCIAL ASSISTANCE POLICY AND PROVIDES ENROLLMENT ASSISTANCE FOR GOVERNMENTAL INSURANCE PLANS.

MERCYONE NEWTON IS INVOLVED IN COMMUNITY COLLABORATIONS AND PARTICIPATES ON LOCAL COMMUNITY BOARDS. THE HOSPITAL PARTNERS WITH COMMUNITY ORGANIZATIONS TO HOST AND SUPPORT COMMUNITY EVENTS, WHICH RAISE AWARENESS OF COMMUNITY HEALTH NEEDS. IN ADDITION, MERCYONE NEWTON COLLABORATES WITH HEALTH EDUCATION PROGRAMS IN THE AREA INCLUDING DES MOINES AREA COMMUNITY COLLEGE, INDIAN HILLS, MERCY COLLEGE OF HEALTH SCIENCES, UNIVERSITY OF IOWA, AND DES MOINES UNIVERSITY.

MANY HOSPITAL LEADERS ATTEND EVENTS IN THE COMMUNITY TO SHOW THE HOSPITAL'S SUPPORT, INCLUDING ROTARY, KIWANIS, AND NEWTON DEVELOPMENT CORE TO NAME A FEW. MERCYONE NEWTON PARTNERS WITH LIFESERVE BLOOD BANK TO HOST

BLOOD DRAW STATIONS. THE HOSPITAL ALSO OFFERS OFFICE SPACE FOR SENIOR HEALTH INSURANCE INFORMATION PROGRAM (SHIIP) SERVICES WITHIN THE HOSPITAL. MERCYONE NEWTON HOSTED THE PINK RIBBON SUPPORT GROUP, A BREAST CANCER SUPPORT GROUP, AT THE HOSPITAL.

MERCYONE NEWTON PROVIDED EDUCATION ON HEALTH AND NUTRITION AT VARIOUS LOCAL EVENTS THROUGHOUT FY25. THE HOSPITAL ALSO PROVIDED COMMUNITY-BASED TRAUMA EDUCATION.

MERCYONE NEWTON SCREENS PATIENTS FOR SOCIAL DETERMINANTS OF HEALTH WHEN ADMITTED TO THE HOSPITAL AND PROVIDES THEM WITH RESOURCES AS NEEDED.

IN FY25, TRINITY HEALTH ASSESSED THE TOTAL IMPACT ITS HOSPITALS HAVE ON COMMUNITY HEALTH. THIS ASSESSMENT INCLUDES TRADITIONAL COMMUNITY BENEFIT AS REPORTED IN PART I, COMMUNITY BUILDING AS REPORTED IN PART II, THE SHORTFALL ON MEDICARE SERVICES AS REPORTED IN PART III, AS WELL AS EXPENSES THAT ARE EXCLUDED FROM THE PART I COMMUNITY BENEFIT CALCULATION BECAUSE THEY ARE OFFSET BY EXTERNAL FUNDING. ALSO INCLUDED ARE ALL COMMUNITY HEALTH WORKERS, INCLUDING THOSE OPERATING IN OUR CLINICALLY INTEGRATED NETWORKS. OUR GOAL IN SHARING THE COMMUNITY IMPACT IS TO DEMONSTRATE HOW OUR CATHOLIC NOT-FOR-PROFIT HEALTH SYSTEM MAKES A DIFFERENCE IN THE COMMUNITIES WE SERVE - FOCUSING ON IMPACTING PEOPLE EXPERIENCING POVERTY - THROUGH FINANCIAL INVESTMENTS.

IN FY25, THE REGIONAL COMMUNITY IMPACT FOR MERCYONE TOTALED \$357.3 MILLION.

MERCYONE NEWTON IS A MEMBER OF TRINITY HEALTH, ONE OF THE LARGEST CATHOLIC HEALTH CARE DELIVERY SYSTEMS IN THE COUNTRY. TRINITY HEALTH'S COMMUNITY HEALTH & WELL-BEING (CHWB) STRATEGY PROMOTES OPTIMAL HEALTH FOR PEOPLE EXPERIENCING POVERTY AND OTHER VULNERABILITIES IN THE COMMUNITIES WE SERVE - EMPHASIZING THE NECESSITY TO INTEGRATE CLINICAL AND SOCIAL CARE.

TRINITY HEALTH CHWB TEAMS LEAD THE DEVELOPMENT AND IMPLEMENTATION OF TRIENNIAL COMMUNITY HEALTH NEEDS ASSESSMENTS (CHNA) AND IMPLEMENTATION STRATEGIES WITH INTENTIONAL FOCUS ON ENGAGING COMMUNITIES AND RESIDENTS EXPERIENCING POVERTY AND OTHER VULNERABILITIES. TO FURTHER OUR COMMITMENT TO ACHIEVING HEALTH EQUITY AND THE COMMON GOOD, THE CHNA AND IMPLEMENTATION STRATEGIES FOSTER COLLECTIVE ACTION TO EQUITABLY ALLOCATE RESOURCES FROM THE HOSPITAL AND OTHER SOURCES TO ADDRESS THESE NEEDS IN COMMUNITIES MOST IMPACTED.

TRINITY HEALTH AND ITS MEMBER HOSPITALS ARE COMMITTED TO THE DELIVERY OF PEOPLE-CENTERED CARE AND SERVING AS A COMPASSIONATE AND TRANSFORMING HEALING PRESENCE WITHIN THE COMMUNITIES WE SERVE. AS A NOT-FOR-PROFIT HEALTH SYSTEM, TRINITY HEALTH REINVESTS ITS PROFITS BACK INTO THE COMMUNITIES AND IS COMMITTED TO ADDRESSING THE UNIQUE NEEDS OF EACH COMMUNITY. IN FISCAL YEAR 2025 (FY25), TRINITY HEALTH CONTRIBUTED NEARLY \$1.4 BILLION IN IRS-DEFINED COMMUNITY BENEFIT SPENDING TO AID THOSE WHO ARE EXPERIENCING POVERTY AND OTHER VULNERABILITIES, AND TO IMPROVE THE HEALTH STATUS OF THE COMMUNITIES IN WHICH WE SERVE. TRINITY HEALTH FURTHERED ITS COMMITMENT THROUGH AN ADDITIONAL \$1.5 BILLION IN PROGRAMS AND INITIATIVES THAT IMPACT OUR COMMUNITIES - YIELDING A TOTAL COMMUNITY IMPACT OF \$2.9 BILLION IN FY25.

TRINITY HEALTH'S COMMUNITY INVESTING PROGRAM FINISHED FY25 WITH MORE THAN \$68 MILLION COMMITTED TO BUILDING VITAL COMMUNITY RESOURCES. THESE FUNDS, IN COLLABORATION WITH 30 PARTNERS, WERE PAIRED WITH OTHER RESOURCES TO GENERATE MORE THAN \$1.1 BILLION IN INVESTMENTS THAT SERVED COMMUNITIES WITHIN TRINITY HEALTH'S SERVICE AREAS. BETWEEN 2018 AND APRIL 2025, THESE INVESTMENTS HAVE BEEN INSTRUMENTAL IN CREATING MUCH-NEEDED COMMUNITY RESOURCES FOR THE PEOPLE THAT WE SERVE, NOTABLY:

- SUPPORTED THE CREATION OF 15,700 UNITS OF AFFORDABLE HOUSING OVER THE LAST EIGHT YEARS (INCLUDING APPROXIMATELY 380 SUPPORTIVE HOUSING BEDS).
- CREATED OR RETAINED AT LEAST 1,300 CHILDCARE SLOTS; 7,600 K-HIGH SCHOOL EDUCATION SLOTS; AND 2,400 EARLY CHILDHOOD EDUCATION SLOTS.
- DEVELOPED AT LEAST 9.3 MILLION SQUARE FEET OF GENERAL REAL ESTATE OVER THE LAST EIGHT YEARS.
- SINCE 2014, 920 STUDENTS HAVE RECEIVED \$2.65 MILLION IN SCHOLARSHIPS THROUGH THE FRESNO STATE AND BOISE STATE SCHOLARSHIPS FUNDS.
- APPROXIMATELY 12,900 FULL- AND PART-TIME POSITIONS HAVE BEEN EITHER CREATED OR MAINTAINED THROUGH PARTNER LENDING.

IN FY25, OVER ONE MILLION PATIENTS SYSTEM-WIDE WERE SCREENED FOR HEALTH-RELATED SOCIAL NEEDS AT THEIR DOCTOR'S OFFICE. OF THOSE SCREENED, 27.4% IDENTIFIED AT LEAST ONE NEED AND MOST OFTEN IDENTIFIED FOOD ACCESS, FINANCIAL INSECURITY AND SOCIAL ISOLATION. AN ADDITIONAL 137,000 PATIENTS WERE SCREENED FOR SOCIAL NEEDS DURING AN IN-PATIENT HOSPITAL STAY WHERE TOP NEEDS INCLUDED FOOD ACCESS, TRANSPORTATION AND HOUSING.

TRINITY HEALTH'S ELECTRONIC HEALTH RECORD (EPIC) INCLUDES A STANDARD SCREENING TOOL FOR PATIENT SOCIAL NEEDS, AND AN INTEGRATED COMMUNITY RESOURCE DIRECTORY THROUGH FINDHELP TO CONNECT PATIENTS TO FREE AND REDUCED COST SUPPORT PROGRAMS. THE COMMUNITY RESOURCE DIRECTORY YIELDED OVER 118,000 SEARCHES, AN INCREASE OF 34% OVER THE PRIOR YEAR. TOP SEARCHES INCLUDED HOUSING, FOOD ACCESS AND HEALTH CARE.

BY COMBINING THEIR LIVED EXPERIENCE AND CONNECTIONS TO THE COMMUNITY WITH EFFECTIVE TRAINING AND INCLUSION IN THE CARE TEAM, COMMUNITY HEALTH WORKERS (CHW) PROVIDE PATIENT-CENTERED AND CULTURALLY RESPONSIVE INTERVENTIONS. CHW'S HAVE MANY COMPETENCIES, INCLUDING PATIENT OUTREACH AND ENGAGEMENT, CONDUCTING ASSESSMENTS, RESOURCE CONNECTION, HEALTH AND SOCIAL SERVICES SYSTEM NAVIGATION, GOAL-SETTING AND PROBLEM-SOLVING THROUGH ONGOING EDUCATION, ADVOCACY AND SUPPORT. IN FY25, TRINITY HEALTH'S 162 CHW'S SUCCESSFULLY ADDRESSED OVER 16,300 SOCIAL NEEDS. ONE SOCIAL NEED (SUCH AS ADDRESSING HOUSING OR FOOD NEEDS) CAN OFTEN TAKE MONTHS, OR EVEN A YEAR TO RESOLVE.

WITH FUNDING THROUGH THE CENTERS FOR DISEASE CONTROL AND PREVENTION, TRINITY HEALTH WORKED WITH 23 PARTNERS AND 47 CERTIFIED LIFESTYLE COACHES NATIONWIDE TO DELIVER THE NATIONAL DIABETES PREVENTION PROGRAM, AN EVIDENCE-BASED, 12-MONTH LIFESTYLE CHANGE PROGRAM. THE GOAL OF THE PROGRAM IS TO LOSE A PERCENTAGE OF BASELINE WEIGHT, ATTEND SESSIONS REGULARLY, AND ENGAGE IN 150 MINUTES OF PHYSICAL ACTIVITY A WEEK. GROUP SESSIONS ARE FACILITATED BY A CDC CERTIFIED LIFESTYLE COACH AND OFFERED IN-PERSON, REMOTELY, OR VIRTUALLY AT A SELF-PACED RATE. ALL PARTICIPANTS ARE REGULARLY SCREENED FOR HEALTH-RELATED SOCIAL NEEDS AND ARE REFERRED TO A CHW TO ADDRESS IDENTIFIED NEEDS. IN FY25, TRINITY HEALTH CONDUCTED FOCUSED OUTREACH WITH NEARLY 165,000 ELIGIBLE PARTICIPANTS AND ENROLLED 1,074 PARTICIPANTS INTO THE LIFESTYLE CHANGE PROGRAM.
