FROM JULY THROUGH NOVEMBER 2022, COMMUNITY INPUT WAS COLLECTED THROUGH FOCUS GROUP CONVERSATIONS WITH COMMUNITY EXPERTS AND COMMUNITY SERVICE AGENCIES WHICH INCLUDED: BAKER COUNTY, BAKER COUNTY CHAMBER OF COMMERCE, BAKER COUNTY HEALTH DEPARTMENT, BAKER EARLY CHILDHOOD EDUCATION PROVIDERS, BAKER SCHOOL DISTRICT 5J, BAKER SAFE FAMILIES, BAKER YMCA, COMMUNITY CONNECTIONS OF NORTHEAST OREGON, COMMUNITY CONNECTIONS SENIOR CENTER, COMPASSION CENTER, FORD FAMILY FOUNDATION, NEW DIRECTIONS NORTHWEST, OREGON DEPARTMENT OF HUMAN SERVICES, AND SAMC-BAKER CITY. SAMC-BAKER CITY UTILIZED THE TRINITY HEALTH DATA HUB AS THE PRIMARY SOURCE TO OBTAIN QUANTITATIVE DATA. ADDITIONAL DATA SOURCES UTILIZED INCLUDED THE U.S. CENSUS BUREAU AMERICAN COMMUNITY SURVEY, COUNTY HEALTH RANKINGS, CENTER FOR DISEASE CONTROL BEHAVIORAL RISK FACTOR SURVEILLANCE SYSTEM, CENTERS FOR MEDICARE & MEDICAID SERVICES, UNITED FOR ALICE, METOPIO.COM, FEEDING AMERICA, FBI CRIME DATA EXPLORER, U.S. DEPARTMENT OF AGRICULTURE, OREGON VITAL STATISTICS, OREGON DEPARTMENT OF EDUCATION, CHILD CARE AWARE OF AMERICA, OREGON HEALTH AUTHORITY, AND THE BUREAU OF LABOR STATISTICS.

IN FY25, SAMC-BAKER CITY COMMUNITY HEALTH WORKERS (CHW'S) SCREENED PATIENTS FOR HOUSING NEEDS AND CONNECTED PATIENTS TO LOCAL COMMUNITY RESOURCES FOR RENTAL ASSISTANCE AND HOUSING SERVICES AS NEEDED. SAMC-BAKER CITY PROVIDED A CONTRIBUTION TO THE COMPASSION CENTER OF NORTHEAST OREGON IN FY25 FOR HOUSING VOUCHERS FOR INDIVIDUALS AND FAMILIES EXPERIENCING HOMELESSNESS.

ACCESS TO AFFORDABLE HEALTH CARE, INCLUDING ORAL AND VISION HEALTH: IN FY25, SAMC-BAKER CITY UTILIZED CHW'S TO CONNECT PATIENTS TO PRIMARY CARE PROVIDERS, ADVOCATE WITH THE LOCAL COMMUNITY ADVISORY COUNCIL TO BRING ADDITIONAL SERVICES TO THE AREA AND CONNECT PATIENTS TO MENTAL HEALTH AND SUBSTANCE ABUSE RESOURCES. IN ADDITION, THE BAKER EARLY LEARNING CENTER WITHIN THE 5J SCHOOL DISTRICT HELPED TO CONNECT STUDENTS AND FAMILIES WITH HEALTH CARE ACCESS.

CAREGIVER SUPPORTS, INCLUDING CHILDCARE AND ASSISTANCE FOR OLDER ADULTS: IN FY25, SAMC-BAKER CITY PROVIDED A CONTRIBUTION TO THE BAKER YMCA FOR THE DEVELOPMENT OF A FAMILY CENTER, PROVIDING EARLY CHILDHOOD EDUCATION AND RECREATIONAL RESOURCES FOR YOUTH.

THEREFORE, SAMC-BAKER CITY IS REPORTING ZERO ON LINE 3, SINCE THEORETICALLY ANY POTENTIAL CHARITY CARE SHOULD HAVE BEEN IDENTIFIED THROUGH THE PREDICTIVE MODEL.

FOR COMPARISON, THE STATE OF OREGON OVERALL HAS A POPULATION DENSITY OF 44.1 PEOPLE PER SQUARE MILE. BAKER COUNTY IS EXTREMELY RURAL AND MOUNTAINOUS, AND PORTIONS OF THE COUNTY ARE FREQUENTLY UNPASSABLE DURING WINTER MONTHS. THE MEDIAN HOUSEHOLD INCOME FROM 2017-2021 WAS \$46,922, COMPARED TO \$70,084 FOR OREGON AS A WHOLE.

THE SURROUNDING COUNTIES TO THE NORTH INCLUDE UNION AND WALLOWA COUNTIES. UNION COUNTY IS SERVED BY GRANDE RONDE HOSPITAL AND WALLOWA COUNTY IS SERVED BY WALLOWA MEMORIAL HOSPITAL. GRANT COUNTY TO THE WEST OF BAKER COUNTY IS SERVED BY BLUE MOUNTAIN HOSPITAL. MALHEUR COUNTY TO THE SOUTH OF BAKER COUNTY IS SERVED BY SAINT ALPHONSUS MEDICAL CENTER-ONTARIO.

BAKER COUNTY IS NOTABLE FOR BEING VERY RURAL AND SPARSELY POPULATED. THE POPULATION HAS A SIGNIFICANTLY HIGHER 65 AND OLDER DEMOGRAPHIC, WITH A MEDIAN AGE MORE THAN 10 YEARS OLDER THAN THE OVERALL U.S. POPULATION. BAKER COUNTY HAS A HIGHER ESTIMATED PERCENTAGE (16.0%) OF PERSONS IN POVERTY THAN THE STATE (12.1%) AND NATIONAL (11.5%) RATES.

SAMC-BAKER CITY PROVIDES A LEVEL 4 TRAUMA CENTER STAFFED 24/7 WITH ONSITE EMERGENCY PHYSICIANS. THIS IS RARE FOR A CRITICAL ACCESS HOSPITAL LOCATED IN A COMMUNITY OF THIS SIZE. LOCAL EMPLOYERS HIGHLY VALUE THIS SERVICE AS IT PROVIDES A SAFETY NET FOR THEIR WORKERS. SAMC-BAKER CITY ALSO PARTICIPATES IN TRAUMA PREVENTION AND DISASTER PREPAREDNESS EFFORTS IN THE REGION.

SAMC-BAKER CITY PARTICIPATES IN A REGIONAL TELEMEDICINE NETWORK WITH AN AFFILIATED TERTIARY HOSPITAL IN BOISE, IDAHO. SERVICES PROVIDED THROUGH THE NETWORK INCLUDED CLINICAL EDUCATION, SPECIALTY PHYSICIAN CONSULTATIONS, AND EMERGENCY MEDICINE CONSULTATIONS. HAVING THIS SERVICE ALLOWS PATIENTS TO BE CARED FOR CLOSER TO HOME.

SAMC-BAKER CITY'S VOLUNTEER COMMUNITY HOSPITAL BOARD FOCUSES ON AREAS LIKE QUALITY, SAFETY, COMMUNITY HEALTH CARE NEEDS, AND MISSION INTEGRATION. THIS BOARD UNDERSTANDS THE VALUE OF MAINTAINING A VIABLE HOSPITAL IN THEIR COMMUNITY AND STRONGLY SUPPORTS THE FACILITY.

SAMC-BAKER CITY CONTINUES TO ADDRESS SIGNIFICANT TRANSPORTATION BARRIERS THROUGH COMMUNITY CONNECTIONS OF NORTHEAST OREGON, A COMMUNITY PARTNER WHO PROVIDES NON-MEDICAL TRANSPORT TO INDIVIDUALS WHO COULD NOT OTHERWISE AFFORD OR OBTAIN TRANSPORTATION TO AND FROM APPOINTMENTS WITHIN BAKER COUNTY.

SAMC-BAKER CITY IS A MEMBER HOSPITAL OF SAINT ALPHONSUS HEALTH SYSTEM (SAHS). IN FY25, SAHS ADDRESSED SOCIAL INFLUENCERS OF HEALTH (SIOH) BY CONTINUING WORK ON A SOCIAL CARE HUB, WHICH CREATED A VIRTUAL LOCATION FOCUSED ON CONNECTING PATIENTS AND COMMUNITY MEMBERS TO LOCAL SOCIAL CARE RESOURCES SUCH AS FOOD, HOUSING, FINANCIAL ASSISTANCE, MEDICATION ASSISTANCE AND ACCESS TO MEDICAL CARE. SAMC-BAKER CITY ALSO PROVIDED TWO COMMUNITY HEALTH WORKERS TO ASSESS THE SOCIAL NEEDS OF STUDENTS AND FAMILIES IN THE BAKER SCHOOL DISTRICT AND PROVIDE REFERRALS TO COMMUNITY PARTNERS AS NEEDED.

SAMC-BAKER CITY IS COMMITTED TO BEING NOT ONLY A TRUSTED HEALTH CARE PARTNER FOR LIFE FOR OUR PATIENTS, BUT A PARTNER IN ADDRESSING THE LEADING SOCIAL INFLUENCERS OF HEALTH BY WORKING IN COLLABORATION WITH GOVERNMENTAL AGENCIES, COMMUNITY-BASED ORGANIZATIONS, AND SERVICE PROVIDERS TO ENSURE WE ARE HELPING OUR COMMUNITIES NOT JUST TO SURVIVE BUT TO THRIVE. SAMC-BAKER CITY PLAYS AN ACTIVE ROLE IN COMMUNITY GROUPS SUCH AS THE YMCA BOARD, RED CROSS, AND BAKER CITY ROTARY CLUB.

SAMC-BAKER CITY ADDRESSED MANY OF THE LEADING SIOH IN THE COMMUNITY THROUGH HOUSING AND HOMELESSNESS WORK, SUPPORTING BEHAVIORAL HEALTH INITIATIVES, AND BY SCREENING AND REFERRING OUR PATIENTS WITH SOCIAL NEEDS (I.E. HOUSING, FOOD, TRANSPORTATION) TO LOCAL COMMUNITY PARTNERS AND RESOURCES TO ADDRESS THEIR NEEDS THROUGH OUR COMMUNITY HEALTH WORKER HUB. THESE SERVICES ARE FREE AND AVAILABLE TO ANYONE IN THE COMMUNITY, REGARDLESS OF THEIR PATIENT STATUS WITH SAMC-BAKER CITY.

IN FY25, TRINITY HEALTH ASSESSED THE TOTAL IMPACT ITS HOSPITALS HAVE ON COMMUNITY HEALTH. THIS ASSESSMENT INCLUDES TRADITIONAL COMMUNITY BENEFIT AS REPORTED IN PART I, COMMUNITY BUILDING AS REPORTED IN PART II, THE SHORTFALL ON MEDICARE SERVICES AS REPORTED IN PART III, AS WELL AS

EXPENSES THAT ARE EXCLUDED FROM THE PART I COMMUNITY BENEFIT CALCULATION BECAUSE THEY ARE OFFSET BY EXTERNAL FUNDING. ALSO INCLUDED ARE ALL COMMUNITY HEALTH WORKERS, INCLUDING THOSE OPERATING IN OUR CLINICALLY INTEGRATED NETWORKS. OUR GOAL IN SHARING THE COMMUNITY IMPACT IS TO DEMONSTRATE HOW OUR CATHOLIC NOT-FOR-PROFIT HEALTH SYSTEM MAKES A DIFFERENCE IN THE COMMUNITIES WE SERVE - FOCUSING ON IMPACTING PEOPLE EXPERIENCING POVERTY - THROUGH FINANCIAL INVESTMENTS.

SAINT ALPHONSUS HEALTH SYSTEM'S COMMUNITY IMPACT IN FY25 TOTALED \$185.2 MILLION.

SAMC-BAKER CITY IS A MEMBER OF TRINITY HEALTH, ONE OF THE LARGEST CATHOLIC HEALTH CARE DELIVERY SYSTEMS IN THE COUNTRY. TRINITY HEALTH'S COMMUNITY HEALTH & WELL-BEING (CHWB) STRATEGY PROMOTES OPTIMAL HEALTH FOR PEOPLE EXPERIENCING POVERTY AND OTHER VULNERABILITIES IN THE COMMUNITIES WE SERVE - EMPHASIZING THE NECESSITY TO INTEGRATE CLINICAL AND SOCIAL CARE.

TRINITY HEALTH CHWB TEAMS LEAD THE DEVELOPMENT AND IMPLEMENTATION OF TRIENNIAL COMMUNITY HEALTH NEEDS ASSESSMENTS (CHNA) AND IMPLEMENTATION STRATEGIES WITH INTENTIONAL FOCUS ON ENGAGING COMMUNITIES AND RESIDENTS EXPERIENCING POVERTY AND OTHER VULNERABILITIES. TO FURTHER OUR COMMITMENT TO ACHIEVING HEALTH EQUITY AND THE COMMON GOOD, THE CHNA AND IMPLEMENTATION STRATEGIES FOSTER COLLECTIVE ACTION TO EQUITABLY ALLOCATE RESOURCES FROM THE HOSPITAL AND OTHER SOURCES TO ADDRESS THESE NEEDS IN COMMUNITIES MOST IMPACTED.

TRINITY HEALTH AND ITS MEMBER HOSPITALS ARE COMMITTED TO THE DELIVERY OF PEOPLE-CENTERED CARE AND SERVING AS A COMPASSIONATE AND TRANSFORMING HEALING PRESENCE WITHIN THE COMMUNITIES WE SERVE. AS A NOT-FOR-PROFIT HEALTH SYSTEM, TRINITY HEALTH REINVESTS ITS PROFITS BACK INTO THE COMMUNITIES AND IS COMMITTED TO ADDRESSING THE UNIQUE NEEDS OF EACH COMMUNITY. IN FISCAL YEAR 2025 (FY25), TRINITY HEALTH CONTRIBUTED NEARLY \$1.4 BILLION IN IRS-DEFINED COMMUNITY BENEFIT SPENDING TO AID THOSE WHO ARE EXPERIENCING POVERTY AND OTHER VULNERABILITIES, AND TO IMPROVE THE HEALTH STATUS OF THE COMMUNITIES IN WHICH WE SERVE. TRINITY HEALTH FURTHERED ITS COMMITMENT THROUGH AN ADDITIONAL \$1.5 BILLION IN PROGRAMS AND INITIATIVES THAT IMPACT OUR COMMUNITIES - YIELDING A TOTAL COMMUNITY IMPACT OF \$2.9 BILLION IN FY25.

TRINITY HEALTH'S COMMUNITY INVESTING PROGRAM FINISHED FY25 WITH MORE THAN \$68 MILLION COMMITTED TO BUILDING VITAL COMMUNITY RESOURCES. THESE FUNDS, IN COLLABORATION WITH 30 PARTNERS, WERE PAIRED WITH OTHER RESOURCES TO GENERATE MORE THAN \$1.1 BILLION IN INVESTMENTS THAT SERVED COMMUNITIES WITHIN TRINITY HEALTH'S SERVICE AREAS. BETWEEN 2018 AND APRIL 2025, THESE INVESTMENTS HAVE BEEN INSTRUMENTAL IN CREATING MUCH-NEEDED COMMUNITY RESOURCES FOR THE PEOPLE THAT WE SERVE, NOTABLY:

- SUPPORTED THE CREATION OF 15,700 UNITS OF AFFORDABLE HOUSING OVER THE LAST EIGHT YEARS (INCLUDING APPROXIMATELY 380 SUPPORTIVE HOUSING BEDS).
- CREATED OR RETAINED AT LEAST 1,300 CHILDCARE SLOTS; 7,600 K-HIGH SCHOOL EDUCATION SLOTS; AND 2,400 EARLY CHILDHOOD EDUCATION SLOTS.
- DEVELOPED AT LEAST 9.3 MILLION SQUARE FEET OF GENERAL REAL ESTATE OVER THE LAST EIGHT YEARS.
- SINCE 2014, 920 STUDENTS HAVE RECEIVED \$2.65 MILLION IN SCHOLARSHIPS THROUGH THE FRESNO STATE AND BOISE STATE SCHOLARSHIPS FUNDS.
- APPROXIMATELY 12,900 FULL- AND PART-TIME POSITIONS HAVE BEEN EITHER

CREATED OR MAINTAINED THROUGH PARTNER LENDING.

IN FY25, OVER ONE MILLION PATIENTS SYSTEM-WIDE WERE SCREENED FOR HEALTH-RELATED SOCIAL NEEDS AT THEIR DOCTOR'S OFFICE. OF THOSE SCREENED, 27.4% IDENTIFIED AT LEAST ONE NEED AND MOST OFTEN IDENTIFIED FOOD ACCESS, FINANCIAL INSECURITY AND SOCIAL ISOLATION. AN ADDITIONAL 137,000 PATIENTS WERE SCREENED FOR SOCIAL NEEDS DURING AN IN-PATIENT HOSPITAL STAY WHERE TOP NEEDS INCLUDED FOOD ACCESS, TRANSPORTATION AND HOUSING.

TRINITY HEALTH'S ELECTRONIC HEALTH RECORD (EPIC) INCLUDES A STANDARD SCREENING TOOL FOR PATIENT SOCIAL NEEDS, AND AN INTEGRATED COMMUNITY RESOURCE DIRECTORY THROUGH FINDHELP TO CONNECT PATIENTS TO FREE AND REDUCED COST SUPPORT PROGRAMS. THE COMMUNITY RESOURCE DIRECTORY YIELDED OVER 118,000 SEARCHES, AN INCREASE OF 34% OVER THE PRIOR YEAR. TOP SEARCHES INCLUDED HOUSING, FOOD ACCESS AND HEALTH CARE.

BY COMBINING THEIR LIVED EXPERIENCE AND CONNECTIONS TO THE COMMUNITY WITH EFFECTIVE TRAINING AND INCLUSION IN THE CARE TEAM, COMMUNITY HEALTH WORKERS (CHW) PROVIDE PATIENT-CENTERED AND CULTURALLY RESPONSIVE INTERVENTIONS. CHW'S HAVE MANY COMPETENCIES, INCLUDING PATIENT OUTREACH AND ENGAGEMENT, CONDUCTING ASSESSMENTS, RESOURCE CONNECTION, HEALTH AND SOCIAL SERVICES SYSTEM NAVIGATION, GOAL-SETTING AND PROBLEM-SOLVING THROUGH ONGOING EDUCATION, ADVOCACY AND SUPPORT. IN FY25, TRINITY HEALTH'S 162 CHW'S SUCCESSFULLY ADDRESSED OVER 16,300 SOCIAL NEEDS. ONE SOCIAL NEED (SUCH AS ADDRESSING HOUSING OR FOOD NEEDS) CAN OFTEN TAKE MONTHS, OR EVEN A YEAR TO RESOLVE.

WITH FUNDING THROUGH THE CENTERS FOR DISEASE CONTROL AND PREVENTION, TRINITY HEALTH WORKED WITH 23 PARTNERS AND 47 CERTIFIED LIFESTYLE COACHES NATIONWIDE TO DELIVER THE NATIONAL DIABETES PREVENTION PROGRAM, AN EVIDENCE-BASED, 12-MONTH LIFESTYLE CHANGE PROGRAM. THE GOAL OF THE PROGRAM IS TO LOSE A PERCENTAGE OF BASELINE WEIGHT, ATTEND SESSIONS REGULARLY, AND ENGAGE IN 150 MINUTES OF PHYSICAL ACTIVITY A WEEK. GROUP SESSIONS ARE FACILITATED BY A CDC CERTIFIED LIFESTYLE COACH AND OFFERED IN-PERSON, REMOTELY, OR VIRTUALLY AT A SELF-PACED RATE. ALL PARTICIPANTS ARE REGULARLY SCREENED FOR HEALTH-RELATED SOCIAL NEEDS AND ARE REFERRED TO A CHW TO ADDRESS IDENTIFIED NEEDS. IN FY25, TRINITY HEALTH CONDUCTED FOCUSED OUTREACH WITH NEARLY 165,000 ELIGIBLE PARTICIPANTS AND ENROLLED 1,074 PARTICIPANTS INTO THE LIFESTYLE CHANGE PROGRAM.
